The total income for the club for the 2018-19 term was \$5323.87, and the total expenditure of the club for this term was \$5482.20.
This results in a total deficit for the club of \$158.33.
The primary cause of this deficit was \$1726.31 in outstanding debts that the past Treasurer had neglected, or was otherwise unable, to pay back until after the 2018 AGM.
This was stated in the previous Treasurer's report, and there was nothing that we were able to do other than accept the debts, pay them back, record them, and move on.
As of 09/03/2019, we have no outstanding debts, and we are waiting on some approved grant payments to be processed, totalling \$280.48.
Should these grants be processed in time for the AGM, we'd be able to report a profit of \$122.15, which would be a huge achievement after starting with such a large debt.
A major reason that we managed to recover so much of the money lost due to this initial debt is that we were able to hit the \$2750.00 grant cap for 2018.
In fact, UMSU granted us an extra \$0.02 on top of the grant cap, possibly due to a miscalculation on their end.
Of course, should they request us to reimburse them for this, we will have no problems doing so.
As a result of careful and diligent management of funds and assets, we can also report that, unlike previous years, there was no discrepancy this year.
